

ROTARY CLUB OF PARADISE INFORMATION SHEET FOR PROSPECTIVE MEMBERS

Our Club Was Chartered April 9, 1946

1. ABOUT THE ROTARY INTERNATIONAL ORGANIZATION

- ▶ Was Founded in 1905 by Paul Harris
- ▶ Includes 1.2 million Rotarians worldwide
- ▶ Is In 166 Countries and Geographical Regions
- ▶ With 530 Districts (Groupings of Clubs) In The World
- ▶ Making Up 35,000 Clubs in the World

2. OUR CLUB IS GOVERNED BY A *BOARD OF DIRECTORS*

There are eleven Directors:

President, Treasurer, Secretary, President Elect, Immediate Past President, and 6 elected by an open Club election.

There are 3 board members elected each year for a 2-year term replacing 3 that go off the Board.

Board Members can serve three consecutive terms but must wait 1 year between election to another term following three consecutive terms.

3. AVENUES OF SERVICE

VOCATIONAL SERVICE - Employer/Employee Relations, Career Information, Four-Way Test, Job Shadow, Mentors, Trade and Professional expertise.

CLUB SERVICE - those committees that support club operations and activities: Secretary duties, Treasurer. Board members, Foundation and Membership Committees. Things that keep the Club operational.

COMMUNITY SERVICE - Doing projects around Paradise that improve the community. Funding other groups that help Paradise. Support local events – such as Johnny Appleseed Days, Gold Nugget Days, Chocolate Fest.

INTERNATIONAL SERVICE - deal with club activities on an international scale: Doing, or supporting international projects through Rotary. Polio Eradication, Wheelchair Distribution, Prosthetic hands installation, Cleft Pallet programs.

YOUTH SERVICE - the positive change implemented by youth and young adults involved in leadership development activities, community and international service projects, and exchange programs that enrich and foster world peace and cultural understanding.

We believe that there is an activity or program in Paradise Rotary to which each member can contribute, in some way.

4. NEW MEMBER SELECTION STEPS

A *Candidate for Membership* is proposed by an existing member (Proposal Package), completed and submitted to the Membership Committee and attend at least 2 meetings in person, usually with their sponsor.

Proposal is reviewed and approved by the Membership Committee.

An interview with the Candidate is conducted to get to know the proposed member, answer any questions and explain what is expected, financial obligations, and opportunities to help the Club and its mission.

The Candidate is "published" for review by the Club's membership for 7 days. AKA 7 day notice

Proposal is acted upon by the Board of Directors.

Proposed member attends a New Member Orientation (spouses and significant others are encouraged to attend)

Proposed member is inducted into the club. Spouses and family are encouraged to attend the induction of new members.

5. FINANCIAL OBLIGATION

Dues are a minimum \$400.00 per year. Dues are billed in two equal parts in November and May.

There is a one-time New Member Initiation Fee of \$100.00 which covers the overhead of processing a new Member into Rotary International. This is paid at time of proposal submission, refunded if not inducted.

Annual *Recognition* or *As Agreed Fines* assessment is suggested at \$150.00 minimum (included in the dues estimation). More than \$150 annually is encouraged. These funds help pay Club overhead costs and can be directed to the Paradise Rotary Foundation on your biannual invoice.

Meals are currently \$20.00 each week. A 10-meal ticket is available for \$200.00. Currently, most meetings are held at the Paradise Recreation and Park Hq, Terry Ashe Center on Skyway in Paradise

Missed Meetings (not made up) are \$20.00 each, added to bi-annual billings.

Early Leavers pay \$5.00 for the privilege of leaving the meeting before the program.

Participation in Club events beyond Weekly Meetings is encouraged and enriching, but not mandatory. Additional costs may be involved.

6. WHAT DOES A MEMBER RECEIVE FOR HIS/HER MONEY?

Fellowship with leading business, professional, vocational and government members of the community, region, and Rotary Clubs worldwide.

Community recognition as a member of a Service Club that is widely known and highly respected *locally and internationally*.

The opportunity to contribute time, talent, and treasure to community projects, regional projects, and International projects alongside fellow Rotarians.

The **ROTARIAN**. Rotary International's monthly magazine. The WE-Cone, Paradise Rotary's electronic newsletter.

The ability to be welcomed at any Rotary Club world wide.

The Club Directory and access to the Club's Database known as DACDB at dacdb.com

7. ATTENDANCE : A Principal Commitment in Rotary

The Meeting Attendance parameter is a fundamental baked into the *Rotary formula for success* by our wise Rotary Leadership. It serves a vital purpose.

A minimum of 50% of the weekly meetings, including a *Makeup Meeting* at another club or Rotary activity.

“Making Up” in Paradise is easy and fun because there are four clubs in our area and almost any Committee Meeting, social attended or project participated in can be submitted as a make-up on dacdb.com.

A missed meeting (without make-up) carries a \$20.00 fee per meeting. Rotarians have 6 months on either side of a meeting date to make up a missed meeting. After attending a “Make Up” Members must enter the proposed Make Up on their own DACdb membership listing to waive the \$20.00 Missed Meeting Fine.

Excessive Missed Meetings in a row, with no Make Ups is cause for membership termination, if not excused by the Board of Directors. A **Leave of Absence** can be granted for illness or other serious situations for up to six months, and no more than two Leaves in a row. **Members must stay current on dues and other financial obligations while on leave.** Members incur no Missed Meeting Fines while on a Leave of Absence.

Applications for Leave of Absence, for allowable reasons, are made through the Club Secretary in writing.

*The first Rotary Club was founded solely on FRIENDSHIP.
They met regularly to solidify that bond of friendship.*

8. HOW CLUB DUES ARE SPENT

A **Rotary Club** is a Service Club. All Service Clubs spend money derived from dues, fund raisers and benefactors. Rotary Clubs do pay for the services of Accountants, Advertisers, Caterers, Venues, Web Hosting Services, and others. All Club Service is by volunteers. There are no paid members. Grant money arrives via specific RI and District rules and procedures and is always applied to specific, documented projects.

To understand how Club Dues are utilized, one must step back and consider the whole of Club Operations. To begin with, our Club runs on an annually reviewed and projected budget created by the Treasurer, Current Club President and incoming Club President. The budget is, of course, just a guideline to work the finances in the coming year. A Rotary Year runs from July 1st to June 30th.

Within Club operations, Dues pay for quite a few items. These are clearly visible in our monthly financial report produced by the Club Treasurer. Aside from RI and District dues, other budgeted amounts are variable year to year.

Remember, though, that Dues go into the Club Treasury, not a specific Dues account. The budget is not solely based on Dues income, but also on expected Fund Raiser income. Also keep in mind that Club Income (Dues & Fund Raisers), Club Expenses, and Budget estimates are all fluid, changing somewhat from year to year.

Rotary International Dues: All Clubs pay Rotary International Dues. Each member's share of annual Rotary International Dues is around \$117.00.

District 5160 Dues: This money pays for Training Assemblies, and District Operational Expenses. Each member's share of annual District Dues is \$65 - \$70.

Rotary Youth Exchange Program: Our Club budgets for this program. Part of this amount goes for a monthly stipend for our sponsored student. The amount varies based on need.

Rotary International Conference: Each year we send our incoming Club President and significant other to the International Conference, paying for plane fare, lodging, and all Rotary related expenses. The benefit is that each incoming Club President gets “the big picture,” inspiring them to provide the superior leadership Rotary Clubs enjoy. The prorated member cost is less than \$80.

Club General Operating Expenses: Last year the budgeted amount for this category was \$5475.00. We spent less. That’s little over \$100.00 per member. This budgeted amount wouldn’t change much for 51 members or 100 members. Each member’s share would obviously be reduced as our membership increased. This category includes 8 items that keep the Club running.

Membership Expenses: Officially termed “Member Expenses,” this budget item pays for items presented to New Members at induction. They include a Rotary Embroidered Polo Shirt, Rotary Logo Pin, and hard copy New Member Packet, which all cost money to obtain.

So, the total from the above “overhead” expenses is \$387.00. Some of them may be lower in any given year. Simply put, Member Dues keep the Club running.

8. Rotary Foundations: There are two Rotary controlled foundations our club members are a part of.

Rotary International Foundation: Known as the Rotary Foundation, a 501C-3 non-profit arm of Rotary International both members and nonmembers contribute to this rated fund <https://www.charitynavigator.org/ein/363245072>. The Rotary Foundation transforms your gifts into service projects that change lives both close to home and around the world. Since it was founded more than 100 years ago, the Foundation has spent more than \$4 billion on life-changing, sustainable projects. With your help, we can make lives better in your community and around the world.

Our mission

The Rotary Foundation helps Rotary members to advance world understanding, goodwill, and peace by improving health, providing quality education, improving the environment, and alleviating poverty.

Areas of Focus:

- Basic education and literacy
- Community economic development
- Disease prevention and treatment (Polio eradication)
- Maternal and child health
- Peacebuilding and conflict prevention
- Water, sanitation, and hygiene

The best part is that after Rotary International uses the donated funds they grant back to Districts and Clubs 1/2 of what is donated for local projects.

Paradise Rotary Foundation: This is our clubs nonprofit 501C-3 arm. Although separate from the Club their mission is to support the philanthropic efforts of the club. The 6 board members serve 2 year terms and must be members of our club. Each year the Club’s president sits as the 7th board member. After the Camp Fire Rotarians and Non-Rotarians donated over 1.2 million dollars to help our club assist in rebuilding our town. The Foundation funded and continues to fund numerous nonprofit, school, affordable housing, arts, safety and rebuilding efforts.
